Privacy

We are concerned about student privacy, and we make every effort to protect student data. Therefore, please be prepared to present an unexpired government-issued picture ID upon every visit to our office. TechLink

TechLink is an internal website designed for students. You can access TechLink by clicking IT Support Students <u>Technology Quick Start Guide</u> or by clicking "TECHLINK" at the top of our website (www.forsythtech.edu) to check the status of your financial aid application and aid offer(s). Tutorials for your first login are available on the TechLink web page. If you have difficulty with accessing TechLink or setting up your password, please contact the Forsyth Tech IT Support Help Desk at 866.517.3567.

Your aid offer, satisfactory academic progress, and important loan notifications will be sent to your Forsyth Tech e-mail. To access your e-mail, you must access TechLink. Your aid offer may be viewed through your *myForsythTech* portal (accessed by an icon within Techlink).

Enrollment Status

Forsyth Tech calculates estimated aid offers based on full-time enrollment (12+ credit hours) for federal funds. Aid estimations for state funds vary. There are more details about this in the sections to follow about financial aid programs. Students may enroll less than full time; however, most aid offers will be reduced. State aid and Federal Direct Loans require at least half-time enrollment.

This applies to all sessions: Fall, Spring & Summer.

Enrollment status is based on enrollment as of the census date for the *full* session. Courses registered for after that census date, are not included in the enrollment calculation.

Financial aid is intended to provide assistance with coursework required for graduation from your approved program of study. Additional coursework will not be covered by financial aid.

A very limited number of academic programs require that financial aid enrollment be calculated on the basis of clock hours which may impact the number of credit hours allowed for enrollment and disbursement. Students in these particular programs of study are notified in their financial aid offer notification emails.

Disbursement of Financial Aid

Your financial aid eligibility for the academic year is provided to you in the form of an offer of financial aid letter, which is available through your TechLink account at *myForsythTech*. Dollar amounts provided on aid offer letters are based on full-time enrollment and are prorated when the

enrollment status is less than 12 credit hours for most forms of aid and less than 15 credit hours for the North Carolina Community College Grant. This is described in more detail in the section above and in the sections to follow that pertain to the various financial aid programs.

Direct Loans are disbursed in two equal installments for every session and require at least 6 credit hours at the time of each disbursement.

A very limited number of academic programs require that financial aid enrollment be calculated on the basis of clock hours which may impact the number of credit hours allowed for enrollment and disbursement. Students in these particular programs of study are notified in their offer of financial aid notification emails.

Courses may not be considered for disbursement until they have actually begun and your class attendance has been confirmed through Forsyth Tech's formal attendance reporting process. We have provided disbursement dates in this guide, but because enrollment varies, disbursement dates for individuals also vary. If you are registered for a class that begins mid-term, for example, your financial aid will not reflect the credit hours for that course until after the attendance for that class has been confirmed. As a result, depending on how many late-start classes you are enrolled in, your financial aid may disburse later than you anticipate or in smaller increments than you expected until all course attendance has been confirmed.

Financial aid must first be used to pay tuition/fees and book/supply charges owed to Forsyth Tech. If there are funds remaining after all college charges have been paid, students will receive a credit balance.

Financial Aid Programs

Federal Pell Grant

This grant program is to offered to students who demonstrate financial need. Aid offers are based on enrollment status and the Expected Family Contribution (EFC) as determined by a federally established formula.

Credit Hours/Pell Amount - Fall, Spring, and Summer Sessions

There are some Federal Pell Grant eligibility ranges that require a minimum enrollment status of six credit hours or more to receive any portion of the aid. Students with an annual Federal Pell Grant aid offer (fall, spring, and summer) of \$2,698 or less may fall into this category. Please

contact the Office of Student Financial Services for more details regarding your minimum enrollment requirements.

Currently, the Department of Education allows up to 150% of a student's Pell Grant Scheduled Aid for the academic year. This is offered as 50% Fall Semester, 50% Spring Semester, and 50% Summer Term. The maximum aid offer per term may not exceed 50%, and disbursement of the full 50% per term is contingent upon full-time enrollment. If the summer disbursement includes any portion of additional Pell Grant funding (any portion over 100%), enrollment of at least six (6) credit hours is required. Please note: To receive the Federal Pell Grant for any term, all eligibility requirements for the Federal Pell Grant must be met, and all terms of Pell Grant disbursements apply towards a student's maximum lifetime eligibility amount of 600%.

Students may receive Federal Pell Grant funds for a maximum of 12 full-time semesters. Application Procedure: Complete the <u>Free Application for FederalStudent Aid (FAFSA)</u> at <u>https://studentaid.gov/.</u>

Federal Supplemental Educational Opportunity Grant (FSEOG)

FSEOG is a federally funded grant offered to students who demonstrate exceptional financial need.

Application Procedure: Complete the Free Application for Federal Student Aid (FAFSA).

Federal Work Study (FWS)

FWS is a federally funded, need-based student work program. Eligible students can work a maximum of 20 hours per week.

Application Procedure: Complete the <u>Free Application for Federal Student Aid (FAFSA)</u>. A Federal Work Study application will be available to students who indicate an interest in FWS on the FAFSA and meet basic qualification standards for the program.

Select students will be contacted to interview for open positions. If a position is offered, more details will be provided regarding the general conditions and terms applicable to any employment provided as part of the financial aid package.

Federal Direct Student Loans

Direct Loans are low--interest loans for eligible students and parents to help pay for costs associated with attending college. Direct Loans are disbursed in two equal installments every session.

Borrowers must be enrolled in and attending at least half--time (6 credit hours) in an eligible program of study at the time of disbursement to receive the loan proceeds.

Direct Subsidized Loans are offered based on financial need. The interest rate changes annually -- for loans first disbursed between July 1, 2020 and June 30, 2021, the interest rate is 2.75%. The government subsidizes or pays the interest due on the loan while the student is enrolled at least half-time, for the first six months after you drop below half-time enrollment (grace period) and during a period of deferment. The government charges a 1.059% origination fee on Subsidized Loans disbursed between 10/1/19 and 9/30/20. This fee is also adjusted annually.

Direct Unsubsidized Loans are offered regardless of need. The interest rate changes annually – for loans first disbursed between July 1, 2020 and June 30, 2021, the interest rate is 2.75%. Interest is

charged on the loan from the time it is disbursed. Students have the option to 'capitalize' the interest due, which will add it to the unpaid principal amount of the loan. Forsyth Tech will always offer the maximum subsidized loan amount before offering any unsubsidized loan amount. The government charges a 1.059% origination fee on Unsubsidized Loans disbursed between 10/1/19 and 9/30/20. This fee is also adjusted annually.

Direct PLUS Loans allow the parent of a dependent student to borrow up to the student's cost of attendance, less other aid received. The interest rate changes annually – for loans first disbursed between July 1, 2020 and June 30, 2021, the interest rate is 5.30%. Repayment begins when the loan is fully disbursed for the year. However, the parent may defer payment while the student is enrolled at least half--time. The government charges a 4.236% origination fee on PLUS loans disbursed between 10/1/19 and 9/30/20. This fee is also adjusted annually.

Application Procedure: Complete the Free Application for Federal Student Aid (FAFSA), and any additional documentation requested by the Student Financial Services office. We will review your eligibility for other types of financial aid first, then offer you the maximum amount of Direct Loans available to you.

Additional Steps Necessary to Receive a Direct Loan: Students must actively confirm that they want all or a portion of the Direct Loan offer(s) in the 'Financial Aid' 'My Awards' section on the MyForsythTech Self-Service portal on TechLink. *First-time borrowers* must also complete Entrance Counseling and sign a Master Promissory Note at <u>https://studentaid.gov/</u> in order for the loan funds to be available to hold classes, buy books and/or receive a disbursement.

Amount Limits: There are annual and aggregate amount limits that apply to Direct Loans. In addition, no student can receive more than the cost of attendance as determined by the school, minus any other financial aid offered. Annual loan amounts for certificate programs will be prorated based on the number of credit hours required for the specific program. More information on loan amounts can be found on our website.

Effective for new borrowers on or after July 1, 2013, there is also a limit on the length of time a student can receive Subsidized Direct Loans. The 150% time limit is based on the length of the student's program of study (i.e. 2 year associate degree x 150% = 3 year time limit to receive Subsidized loans).

Direct Loans are disbursed in two equal installments every session.

As stated previously, borrowers must be enrolled and attending at least half-time (6 credit hours) in an eligible program of study. Should a borrower reduce enrollment or attendance hours below half-time, an email will be sent with information regarding exit counseling.

North Carolina Community College Grant (NCCCG)

The NCCCG is available to North Carolina residents who demonstrate financial need and are enrolled at North Carolina Community Colleges. Lifetime eligibility limits may apply to this grant.

Please note: Students with an annual NCCCG offer of \$600 (or semester amount of \$300) or less must be enrolled in 15 credit hours to receive any portion of this aid. Other NCCCG aid amounts may have a minimum enrollment status as well, and no NCCCG offer can be made for less than 6 credit hours.

Eligibility: Applicants must meet the following eligibility requirements:

- Be a North Carolina resident for tuition purposes
- Meet all eligibility requirements of a Federal Pell Grant, except the Expected Family Contribution (EFC) requirement
- Enroll for at least six credit hours per semester as an undergraduate student in a degree, certificate or diploma program (some NCCCG offers may require more credit hours)
- Students who have already earned baccalaureate (four-year) college degrees are noteligible.
- Meet <u>Satisfactory Academic Progress</u> requirements
- NC Community College Grants are not available for summer sessions.

Application Procedure: Complete the Free Application for Federal Student Aid (FAFSA).

North Carolina Education Lottery Scholarship (NCELS)

The NCELS program was created by the 2005 General Assembly to provide financial assistance to North Carolina students showing financial need, attending eligible colleges and universities located within the state of North Carolina.

Credit hours/NCELS Amount – Fall and Spring Semester

Please note: Students with an annual NCELS offer of \$132 or less must be enrolled full-time to receive any portion of the offer.

Eligibility: Applicants must meet the following eligibility requirements:

- Be a North Carolina resident for tuition purposes
- Enroll for at least six credit hours per semester in a curriculum program
- Meet <u>Satisfactory Academic Progress</u> requirements
- Be admitted, enrolled, and classified as an undergraduate student in a matriculated status in a degree, certificate, or diploma program
- Meet all eligibility requirements for the Federal Pell Grant
- Students who have already earned baccalaureate (four-year) college degrees are not eligible.
- NC Education Lottery Scholarships are not available for summer sessions.

Application Procedure: Complete the Free Application for Federal Student Aid (FAFSA).

Verification of Aid Application

Students who are selected for verification are sent a letter and an email specifying the documents that need to be submitted to the Office of Student Financial Services. Federal and state financial aid will not be offered until

the required information is submitted and verified. In order to be considered for all available funds, required documents must be submitted within 45 days of notification and no later than August 1. Verification documents will be compared to FAFSA data. If an error is discovered, an electronic correction will be submitted by the office to the Central Processing System and may change the student's Expected Family Contribution (EFC). An offer of financial aid will be made only after the data has been verified to be correct. If, during the verification process or at any time, it is determined that fraudulent information was purposely provided on the FAFSA or during the application completion process, we are required to refer that information to the Office of the Inspector General and may do so by phone call, email, or letter. Failure to submit the required documentation will result in an incomplete financial aid application.

Courses Not Eligible for Aid

The following courses are not counted toward enrollment status when determining financial aid eligibility:

- BSP Courses
- Economic Workforce and Development (continuing education)
- Audit courses or courses classified as Special Credit
- More than 30 hours of developmental or refresher course work
- Passed courses repeated more than once
- Courses registered for after the census date of the full term
- Courses outside of the curriculum graduationrequirements

Academic Programs Eligible for Financial Aid

In order to be eligible for financial aid, students must be enrolled in an eligible post-secondary program of study. A classification of Special Credit is not eligible for financial aid, but most associate degree programs (AA, AS, AFA or AGE) are, as well as many diploma and several certificate programs. Students are notified by the Office of Student Financial Services if their program of study is not approved for financial aid. For inquiries about a specific program of study, contact the Office of Student Financial Services.

Consortium Agreements

Students wishing to complete coursework at two schools at one time may request consideration for a consortium agreement, however, no blanket requests will be provided. If serving as the visitor school, Forsyth Tech will review how many credits the student is taking at each school to determine whether to enter into an agreement. When serving as the home school, the student must be enrolled at Forsyth Tech at least half-time (at least 6 credit hours), and the coursework taken at the visitor school must be acceptable for the student's Forsyth Tech graduation requirements. Students wishing to study abroad may inquire with the Office of Student Financial Services to determine whether a course would qualify.

Forsyth Tech Refund Policy

- A 100% refund may be given if students officially withdraw prior to the first day of class(es) of the session as noted in the academic calendar. If Forsyth Tech cancels a course, the portion of tuition the student paid for the canceled course will be refunded in full.
- For classes beginning at times other than the first week (seven calendar days) of the semester a 100 percent refund shall be made if the student officially withdraws from the class prior to the first day of class meeting. A 75 percent refund shall be made if the student officially withdraws from the class prior to or on the 10 percent point of (census date) the class.

- Student activity fees will be refunded only when classes are canceled and students are not registered in any other class.
- Students passing proficiency exams for courses they have registered and paid for are not eligible for tuition refunds.
- Tuition refunds are not transferable to other individuals.
- Late tuition refund requests will not be considered.
- Tuition cannot be held from one semester to a future semester.
- Malpractice insurance and the College Access, Parking and Security (CAPS) fees are non-refundable unless the class(es) are canceled by the school.

Students may drop class(es) using the "Online Course Drop Form" located on TechLink. If you have questions, contact the Cashier's Office at 336.734.7210.

Attendance Requirement – Avoid Owing Money Back, Stay in School!

Students must attend class(es) to be eligible for aid. Students who stop attending all courses and/or officially withdraw from all courses and are receiving federal financial aid or state grants are only eligible for the portion of financial aid that corresponds to the amount of time they attended as prescribed by federal and state regulations.

Students are considered to "earn" their financial aid by attending class. Students withdrawing from all courses after the 60% point of the semester are considered to have earned 100% of their aid. However, withdrawals still impact Satisfactory Academic Progress.

Students who withdraw or stop attending courses before the 60% point has been reached are required to repay the U.S. Department of Education any "unearned" funds. Students who never attend courses or are reported as "no shows" are not entitled to any aid for those courses.

However, it is possible that students may still be responsible for tuition/fees for "no show" courses. For complete details, feel free to request a copy of the full policy from the Office of Student Financial Services.

NOTES:

*Please note, financial aid is paid only for classes that you attend. If you are taking courses that begin after the first official day of the semester (a course that starts mid-term, for example), payment for that coursework will be reflected at a later date after that course actually begins and your attendance has been confirmed. For more details on payment dates, feel free to contact the Office of Student Financial Services.

**Financial aid is disbursed only for courses required for your current program of study. Additional coursework taken outside of your program of study does not figure into the number of credit hours calculated for financial aid disbursement purposes. A course outside of your program of study would be any course not specifically required for completion of the degree. Note: required remedial coursework can be included for a maximum of 30 credit hours.

***Federal student loans are disbursed in two equal installments per semester. The first disbursement will occur mid-way through the first half of the semester, and the second will occur mid-way through the second half of the semester. Federal student loan eligibility requirements must be met in order to receive the federal student loan disbursement. Students must have met the Entrance Counseling and Master Promissory Note (MPN) requirements and be enrolled (and attending) a minimum of 6 credit hours.

Satisfactory Academic Progress Policy

Federal regulations require that students receiving Title IV financial assistance must maintain satisfactory academic progress (SAP). At Forsyth Technical Community College, satisfactory academic progress is measured using three standards, Cumulative Grade Point Average (GPA), Completion Rate - the percentage of credit hours attempted that are successfully completed, and the maximum number of credit hours allowed before graduation from the student's program. These standards are checked at the end of each semester/term for students receiving financial aid who are enrolled in credit hour programs. For financial aid students enrolled in clock hour programs, SAP is checked at the end of each payment period.

Cumulative GPA - A student must maintain at least a 2.00 *cumulative* grade point average. Transfer credits, credits by examination, P and R grades are not counted as part of the GPA calculation. A "WF" grade is counted as an "F". A class that has been repeated will have the last grade received counted in the GPA.

Completion Rate - A student must complete, with a letter grade of A, B, C, D, or P, at least 67% of all coursework attempted. This includes <u>every</u> course (a cumulative history) on their Forsyth Tech transcript. Transfer courses accepted by the College are included in addition to all courses taken at Forsyth Tech. Hours for each attempt of a repeated course will be included. However, courses dropped during the 75% refund period are not shown on the transcript and, therefore, are not counted. Once a student graduates from a program, the completion rate starts over if the student enrolls in a new program. WE grades received during the Spring Semester, 2020, as a result of a COVID-19 emergency will not count as either attempted or completed. Students receiving an IE grade Spring Semester, 2020, must work with their instructor to complete the coursework within the timeframe allowed by the instructor, no later than December 9, 2020. IE grade(s) for coursework not completed will be converted to F grades on transcripts by the end of Fall Semester, 2020, which will be calculated as attempted but not completed. The F grade will also impact your cumulative GPA.

Credit Hour Limitation: Students are required to complete programs within a maximum credit hour limitation, excluding up to 30 hours to complete any necessary remedial courses determined by institutional testing. In addition, a grade of WE Spring Semester, 2020, will be excluded from consideration. The maximum may not exceed 150% of the number of credits required for the program. For example, a student enrolled in a program that requires 64 credits for graduation may receive federal aid for up to 96 hours. All periods of enrollment, regardless of whether or not the student received aid, are included. Withdrawals, incompletes, repeated courses, transfer credit, and credit by examination will count toward the 150% credit hour limitation. The college is required to suspend aid eligibility as soon as it is determined that the student cannot meet the 150% requirement. If a student has not completed the graduation requirements for the program by the 120% point, the aid office will review the student's record to determine if the student can graduate on time and keep their aid. For students in clock hour programs, they must complete a maximum of the number of clock hours required for the program within a maximum of 150% of the number of weeks required for the program.

Incomplete: Incompletes will count as credit hours attempted, but not completed.

Withdrawal: All grades of W, WP, and WF will count as credit hours attempted but not completed. "WF" will count as an "F". "WE" grades were issued in Spring Semester, 2020, for students with COVID-19 emergencies. These "WE" grades will not be calculated as either attempted or completed.

Repeated Course: Repeated courses count as credit hours attempted for each enrollment.

Audit or Credit by Examination: Audits and proficiency exams are not covered by any type of financial aid. Students are responsible for all costs incurred with these types of courses. Credit by exam hours do count toward credit hours attempted and earned. Audits do not carry credit hours and are not counted as attempts or completions.

Program Change: Students who change programs should be aware that all hours attempted, regardless of the program, will count toward the maximum credit hour allowance until the student graduates. Students who graduate from one program, and wish to earn another Associate Degree, Diploma, or Certificate will be allowed to complete a new program within a new 150% credit hour allowance.

Academic Forgiveness: Forsyth Technical Community College sometimes allows academic forgiveness for academic purposes. However, it is not allowed for financial aid. Both the grade and the credits will continue to be included in the satisfactory academic progress calculation.

Consequences of Failure to Maintain Satisfactory Academic Progress: Students receiving financial aid who do not satisfactorily complete either the cumulative GPA or the completion rate will be placed on financial aid *warning*

status. Students will be sent an email through the campus email system. A student who has not met the requirements will have the next enrolled term to reestablish satisfactory academic progress. If a student does not earn the required cumulative grade point average and completion rate at the end of the following term, he/she will be ineligible for financial aid and will be placed on financial aid *suspension* status. Federal and state aid will remain suspended until the student enrolls for subsequent semesters/terms, at his or her own expense, and completes the work necessary to regain satisfactory progress. If it is determined the student cannot complete the program graduation requirements within the 150% time frame, the student will be ineligible for financial aid until the student graduates from a program.

Note: Maintaining satisfactory academic progress for financial aid may not be the same as remaining in good standing in the program. Each program has its own requirements. As a result, even though a student may meet satisfactory progress for financial aid purposes, they may not be meeting the requirements necessary to continue in their program. It is the student's responsibility to know his or her program requirements.

Appeal Procedures for Financial Aid Suspension: Students whose financial aid has been suspended due to unsatisfactory progress may appeal this decision. However, the student must be able to document mitigating circumstances. A student must indicate in writing to the Office of Student Financial Services why the aid should not be terminated. The student must explain why satisfactory progress was not maintained and what has changed to allow the student to be successful. Appeals may be made if there are unusual situations such as injury to or illness of the student, death of a family member, undue hardship, or other serious crisis. External documentation may be required. The appeal will be reviewed to determine whether or not reinstatement of aid is justified, and the student will be notified of the decision by email. If the appeal is approved, the student will be placed on academic probation which will allow another term of financial aid; the student will be given an academic plan that must be met at the end of each subsequent enrolled term or until the student returns to satisfactory progress. The academic plan generally requires a term GPA of 2.25 and a 75% completion rate; under certain circumstances different requirements may be set. If the appeal is not approved, the student has the right to submit a second appeal to the Forsyth Technical Community College Financial Aid Advisory Committee. The Advisory Committee's decision will exhaust all avenues of the appeal process. If the student's first appeal is approved but the student does not meet the academic plan, financial aid will be terminated until the student has returned to satisfactory academic status. All students are permitted a second appeal, but students who are terminated from their probationary status must wait a term before a second appeal will be considered. All second appeals are considered by The Advisory Committee, and their decision will exhaust all avenues of the appeal process. Two appeal requests are the maximum allowed per student regardless of whether the appeals were approved or not.

For students receiving financial aid, Satisfactory Academic Progress notifications will be sent to the Forsyth Tech campus e-mail address after grade posting in the fall, spring and summer. Students may access this e-mail via TechLink at www.forsythtech.edu/techlink.

If, at any time during the year, students have any questions about financial aid, they should call or come by the Office of Student Financial Services.

Scholarships

Many Forsyth Tech Foundation scholarships are available to Forsyth Tech students each year. The general scholarship application period for the 2020-2021 academic year is April 1, 2020 – April 30, 2020. During this time period, applications are available online at

<u>forsythtech.academicworks.com</u>. Scholarships established through the generosity of community businesses, organizations, and individuals may be limited to students majoring in specific professions.

purposes, the national percentage is 9.7%, and the percentage among other public 2-3-year colleges is 15.2%. Forsyth Tech has partnered with Student Connections to help student borrowers avoid loan default. Student borrowers are also highly encouraged to work with their loan servicer(s) when facing hardships with loan repayment. There may be options available to assist.

- I understand that in some instances aid amounts are estimated and subject to change based on available funding and/or regulatory changes.
- I understand that false or incomplete information submitted by me or on my behalf may result in the cancellation of my aid and may require repayment of part or all of the funds disbursed to me.
- I agree to repay any funds disbursed to me in error or for any period of time I was not eligible or enrolled. I understand that if I should be over-awarded and repayment is required, I will be ineligible to receive additional financial aid funds at this college, or at any other college, until full repayment is made. I understand that money that could be disbursed in the form of a balance may be used instead to repay any debt owed to the College.
- I understand that if I receive financial assistance from Forsyth Tech, I am required to notify the Office of Student Financial Services if I receive any other scholarships, loans, employer reimbursement or other assistance from sources outside the College prior to acceptance of outside aid.

Books and Supplies

Additionally, students must provide the Student Financial Services department a written statement (on letterhead) from the off-campus vendor that indicates that the vendor will (a) allow the student to make a charge against his/her account and (b) bill the College within the seven-day period after the first day of the semester.
