Educational Preparation: Forsyth Tech's AEMT program builds upon EMT-level skills by introducing limited advanced care procedures, including intravenous therapy, medication administration, and advanced airway management. Individuals holding an AEMT certification can practice in a variety of settings, such as 911 emergency response, backup 911 response, convalescent transport, critical care transport, emergency rooms, urgent care centers, and other clinical environments.

Licensure and Certification: Graduates are eligible to take the North Carolina AEMT credentialing exam and the National Registry (NR) AEMT exam. While NR certification is recognized in other states, each state may have specific requirements or endorsement processes. Students planning to practice outside North Carolina should consult the appropriate state EMS agency for guidance.
