Educational Preparation: Forsyth Technical Community College's Auto Safety Inspection and OBD II program trains students in the procedures and regulations necessary to conduct vehicle safety and emissions inspections in compliance with state and federal guidelines. The course focuses on safety system evaluation, emissions control, diagnostic procedures, and the proper use of inspection tools and databases.

Licensure and Certification: In North Carolina, individuals must complete a state-approved training course and pass a written exam administered by the NC Division of Motor Vehicles (DMV) to become certified to perform safety and/or OBD II emissions inspections. Requirements vary across states—some maintain independent inspection licensing, while others incorporate it into broader mechanic certification. Students should consult their state's DMV or environmental agency for current regulations and certification pathways.
