Educational Preparation: Forsyth Technical Community College's Certified Clinical Medical Assistant (CCMA) program prepares students to assist healthcare providers in outpatient settings with both administrative and clinical tasks. The curriculum includes training in patient intake, vital signs, medical terminology, EKGs, phlebotomy, and administrative procedures. Upon completion, students are eligible to sit for the National Healthcareer Association (NHA) Certified Clinical Medical Assistant (CCMA) exam.

Certification and State Requirements: Clinical medical assistants are not licensed at the state level, but most employers require or strongly prefer certification. The CCMA credential through the NHA is nationally recognized and commonly accepted in physician offices, clinics, and other ambulatory care environments. Students should check with employers or their state's health department to confirm any additional local training, certification, or registration requirements.
