This document is designed to assist in understanding the varying educational and credentialing requirements for Community Health Workers (CHWs) on a state-by-state basis, encompassing the United States territories as well.

Educational Preparation: The Community Health Worker program at Forsyth Technical Community College equips students with the foundational knowledge and interpersonal skills necessary to provide frontline support in healthcare settings, public health agencies, and community-based organizations. The course is designed to provide individuals with the tools and resources required to become recognized as a certified CHW in North Carolina. Instruction covers nine core competencies essential to the role, including communication, capacity building, service coordination, interpersonal skills, advocacy, outreach, and professionalism. Students also gain knowledge of social and health issues such as chronic diseases (e.g., diabetes, asthma, cancer), safety, emergency preparedness, social isolation, and adverse childhood experiences (ACEs). In addition, students are introduced to the changing healthcare landscape in North Carolina and how to connect clients to resources through systems like NCCARES 360.

Certification and State Recognition: Certification requirements for CHWs vary widely by state. Some states maintain voluntary registries or require certification through a state agency, while others allow employers to set credentialing standards. In North Carolina, successful completion of Forsyth Tech's program makes students eligible for listing as a NC Certified Community Health Worker. Individuals in other states should consult their Department of Health or CHW Advisory Board for specific guidance.
