Educational Preparation: Forsyth Tech’s Nuclear Medicine program prepares students to administer radioactive substances and operate imaging equipment for diagnostic and therapeutic purposes.

Licensure and Certification: Many states require licensure, and almost all employers require national certification through the ARRT (Nuclear Medicine Technology Certification) or the NMTCB (Nuclear Medicine Technology Certification Board). Regulations vary, so students should confirm requirements with their state’s radiologic health board or department of health.
