Forsyth Tech's Paramedic Academy offers the highest level of prehospital EMS training, preparing students to perform advanced life support (ALS) interventions in both medical and trauma emergencies. Through a combination of classroom instruction, lab sessions, and clinical experiences, students will learn to conduct advanced patient assessments, interpret electrocardiograms (ECGs), perform endotracheal intubation and other advanced airway procedures, administer a wide range of medications, establish intravenous (IV) and intraosseous (IO) access, and manage cardiac, respiratory, and traumatic conditions. Graduates who successfully complete the course and pass the certification exam are eligible to work in a variety of settings, including 911 emergency and backup response, convalescent transport, critical care transport, emergency departments, urgent care centers, and other clinical environments.

Upon completion of the program, students are eligible to sit for both the North Carolina Paramedic and the National Registry (NR) Paramedic exam. While the National Registry (NR) certification is recognized in other states, each state may have specific requirements or endorsement processes. Students planning to practice outside North Carolina should consult the appropriate state EMS agency for guidance.
